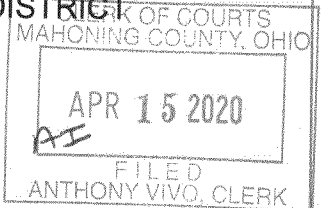

**FAX AND EMAIL FILINGS WITHIN
DOMESTIC RELATIONS COURT**

Pursuant to the emergency orders filed by this court on March 16, 2020 and March 17, 2020, and in response to the existing public health crisis, the Mahoning County Domestic Relations Court issues the following order which is intended to assist in protecting the public health and to maintain essential court functions.

THEREFORE, IT IS HEREBY ORDERED:

During the existing health crisis and until further order of the court, the Mahoning County Domestic Relations Court shall accept any pleading or paper filed via fax or email transmission. Such fax and email filings shall be in addition to any existing methods acceptable by the court through the Office of the Mahoning County Clerk of Courts. Any party or counsel utilizing the filing method of fax or email shall be required to first submit such pleading or paper with the court which will then be forwarded to the Office of the Mahoning County Clerk of Courts. Any deposit or cost associated with such filing shall be due and received by the court via regular mail within three (3) days of the faxed or emailed filing.
